Three days of member meetings, agency leadership meetings and legislative visits – much accomplished and appreciated.

Every year our annual DC Mission presents a set of "mission" goals of sharing and learning with our PCC association members. This DC mission visit was an exceptionally interesting and necessary.

Day One was Board meeting with all the five West Coast members associations. Key points shared was some FDA meetings canceled, and as CBFANC recently learned also, due to HHS directive: "HHS has issued a pause on mass communications and public appearances that are not directly related to emergencies or critical to preserving health. This is a short pause to allow the new team to set up a process for

review and prioritization. There are exceptions for announcements that HHS divisions believe are mission critical, but they will be made on a case-by-case basis." This statement is an example of the tone felt across agencies before and widely infused from daily "Breaking News" newsfeeds.

One concern shared by Keira Conlan with Washington State association concerned NW Seaport Alliance announcing the cession of services at Seattle port's SSA Terminal 30. "SSA Terminals (Seattle), LLC ("SSA") is the terminal operator under lease at Terminal 25/30. On or about August 1, 2024, SSA provided NWSA with notice of its intent to cease operations at Terminal 30 by January 1, 2025, citing concerns regarding recent legal rulings regarding stormwater and the requirements of the forthcoming 2025 Washington Industrial Stormwater General Permit (ISGP). Since SSA's notice, the parties have been in ongoing discussions to evaluate alternatives to SSA's departure from Terminal 30 and have not yet reached a resolution, to read full memorandum, please click here.

Another concern from Seattle. Proposed December 16th, 2024, a \$15.00 charge across all Seattle and Tacoma seaport terminals. The "service fee" proposed, per transaction, promotes 75 minutes turn times? Advent eModal now owned by CargoSprint, would collect the fee. The discussion on eModal prompted board discussion on eModal being the dominates appointment system and fee collection system across majority of ports. This is a concern for Port of Oakland motor carriers and port stakeholders as well. Because eModal is the only appointment system in Oakland terminals, when the system is down, all port activity is shut down. In recent years, down times, delays and glitches has caused operations to cease and truckers outrage over extended outages. A watch for CargoSprint-Advent eModal to further monopolize and monetize at the ports – seaport and airports?

Day Two were our morning sessions with CBP Leadership. Executive Assistant Commissioner Anne-Marie Highsmith opened the sessions with assurances on the continued trade mission of CBP but with (understandable) cadence on adapting guidance from recent Executive Orders. Much said on enforcement – fentanyl/precursors, interceptions (border, USPS, eCommerce), 232), 301 Tariffs. Of which the latter, Tariffs reign with much use of word "Revenue" In fact, the term "External Revenue Service" was proposed with CBP partnership for Treasury and Commerce and as Collection Service.

Di Minimus status remains uncertain and the 4 ½ days disrupted shipments also remain unresolved in systems and warehouses. Other than that and other policy decisions/guidance, more updates on broker education and outreach will be available on CBP website by summer. Another important topic is bond sufficiency. Citing 19CFR142, bond sufficiency is a priority and yet, with trade policy eclipsed by Executive Order actions, everyone is scrambling to understand what impacts and necessary safeguards with/out collateral necessary sooner rather than too late. Additionally, if renewed, it appears GSP may not be retroactive. After four years, the refund value is too large and may now be needed as an offset "tax revenue".

Peter Friedmann invited a great speaker Ted Murphy with Sidley Austin Law Group. A few high-level highlights to share are below. Best quote from Ted Murphy: "Trump has little picture of Trade" versus big picture of Trade.

- · Governments don't do trade so what are...
- · Incentives to do trade
- Trump "trade" policies may be the "kick start" to be outside of World Trade Organization (WTO)
- If countries don't' trade, what are the Incentives

- Trump Tariffs 2.0 is very different from Trump 1.0 (levelage vs revenue)
- Reciprocal Tariffs what will it be is anyone's guess
- As if Congress would codify tariffs, yes, they could (but then Congress would have to pass legislation again to rescind)

Afternoon sessions were Consumer Product Safety Commission (CPSC) Deputy Director, CPSC Office of Import Surveillance Sabrina Keller and USDA Lacey Act with Dr. Robert Baca Assistant Director, Permitting and Compliance Coordination, Compliance and Environmental Coordination Branch, PPQ, APHIS. Updates from these sessions to be shared in next newsletter.

Separate meetings with Federal Maritime Commission (FMC). Chairman Louis Sola and Commissioner Rebecca Dye and then Commissioners Dan Maffei and Max Vekich. While PCC association members expressed appreciation on the Ocean Shipping Reform Act (OSRA) and FMC's Consumer Affairs and Dispute Resolution Services (cadrs@fmc.gov) assisting resolutions for unreasonable charges, much work still needed. We were pleased to hear from FMC Chairman Louis Sola, when asked on data automaton (to trade), he said FMC plans to work and other needed projects.

During meetings with FMC, Jordan Zeldin with Avalon Risk Management presented letter to Commissioners on behalf of the Harbor Trucking Association (HTA. The letter dated February 14, 2025 to FMC Rebecca Dye cites the "Concerns of Blocked Third-Party Appointment Software access; Threats of Blocking Motor Carriers Access to Appointment System Platform". wants to block third-party software access. HTA CEO Matt Schrap summarized the harm and issued action request to the Commission: "We are concerned that eMododal's actions could hinder operational efficiency, stifle innovation, and disrupt the free flow of goods. The technological advances of third-party software providers have alleviated many of the challenges felt by moto carriers for appointment system-based management. As drayage providers to the terminals of San Pedro Bay, motor carriers have no choice but to use eModal and agree to their Terms of Service for securing appointments – restricting access to 55% of terminals in the area would be unsustainable and the threat of such feels unfairly restrictive to trade."

Day Three PCC Mission Hill visits. As Customs Brokers and Freight Forwarders, our group is one of the few organizations talking trade to Senators and House Representatives. CBFANC members as constituents met with Congressional staffer to exchange and continue dialogue on trade and supply chain. Last meeting of the day and highlight was Oregon Senator Ron Wyden who graciously joined part of our annual Senate Finance meeting. With Portland delegation lending cred, this huge highlight and reminder for the effectiveness of home district connection.
